GUIDELINES FOR APPEAL REQUEST

(Pechanga Code of Ordinances Title 8, Divisions 2 & 3, Article 1, Section 1.21)

- Applicants may file appeals of decisions or determinations made by the Building Official or Fire Code Official relative to the application and interpretation of the Ordinance. Any such appeal must be submitted within fifteen (15) days after the date of such decision or determination.
- The application shall indicate the specific decision to be appealed, the grounds of the appeal and the relief or action sought from the Tribal Council.
- Appellants shall be allowed to present evidence in support of their appeal during a hearing before the Tribal Council. The Tribal Council will retain subject matter experts to assist and advise any appeal filed hereunder as deemed necessary. The Tribal Council shall render a final decision with respect to the decision or determination being appealed. The process described in Section 1.21 (Administrative Appeal Process) under the Ordinance is within the exclusive jurisdiction of the Pechanga Band and its agencies and officers, and is the sole recourse for any person filing an appeal pursuant to the Ordinance.
